FEIF Sport Judges Seminar 2024 March 23-24, 2024, Laholm, Sweden

Join us in Southwest Sweden for an exciting weekend!

The seminar will be held at the Sundabakki Islandshästar in Laholm, Sweden on Saturday and the Elite Hotel Plaza Marina, Helsingborg, on Sunday. The programme will include judging performances on the oval track, with special focus on the relationship between connection and outline in tölt (practical judging), and an in-depth look at walk and canter (lectures).

- **Main themes: Connection & outline, walk, and canter**

The entire seminar will be held in English and is both theoretical and practical.

Eligible participants:

International FEIF Sport Judges have priority. Interested persons not listed as International FEIF Sport Judge can register for the waiting list and will receive confirmation of a seat by February 1, 2024. Waiting list places will be distributed in the order of registration.

The maximum number of participants is limited to 70 participants, as soon as the maximum number of participants has been reached, the registration for the seminar will close.

License:

Judges with a FEIF license have to attend at least one full FEIF Sport Judges Seminar in the three years period before the expiration date of their license and have to be an active judge for at least 15 days at WorldRanking events in this period. For judges with a FEIF license with an expiration date of December 2024, this seminar is their last chance to renew their license if they didn't attend the required seminar earlier.

The Board of FEIF has decided to have the second seminar per judges for free every three years (the license period). The offer includes the seminar fee plus food and included beverages, but not hotel rooms, transport or side programme. Registration for the seminar using the free option is only possible during the early bird period.

Venue: Sundabakki Islandshästar Edenbergavägen 33, 31295 Laholm, Sweden

Nearest airport: Copenhagen, Denmark (about 1 hour from Copenhagen airport to the hotel, 1:35 from the airport to Sundabakki Islandshästar).

Trains leave frequently from Copenhagen airport to Helsingborg, either via Malmö and Lund in Sweden, or up the east coast of Sjælland, Denmark, with the short ferry from Helsingør. The train from the airport to Helsingborg is 1:10 with the fastest (direct) train.

- From the ferry at Helsingborg the hotel is approx. 10 minutes by car/taxi or 20 minutes' walk.
- From Helsingborg train station to the hotel it is approx. 6 minutes walk.
